• Further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity, I fully understand that:
a. Bicycling activities involve risk and dangers of serious bodily injury including permanent disability, paralysis and the risk of death.
b. These risks and dangers may be caused by my own actions or inactions of others participating in the activity, the conditions which the activity takes place, or the negligence of other participants.
c. There may be other risks and social economic losses, either not known to me, or, not readily foreseeable at this time. I fully accept and assume all risks and all responsibilities for loses, costs, and damages I incur as a result of my participating in the above activity.
• I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless Hiawatha Bicycling Club (HBC), Its board of directors and the TDA ride director, the League of American Bicyclists (LAB), their representatives, administrators, directors, agents and employees, other participants, any sponsors, advertisers, and if applicable, otherwise including negligent rescue operations.
